

Greater Rhode Island Chapter Scholarship Program

Greater Rhode Island Chapter values education and ethics, and has established a scholarship program through the IREM Foundation Scholarship Program to further the profession of property management and benefit the chapter and its members.

The Chapter's intent by awarding scholarships is to recognize Property Managers who have the most potential to become leaders in the profession, to encourage those who are most likely to obtain their CPM or ARM designation in a timely manner, and to support members who are active in the chapter and will continue to benefit the chapter by their participation.

Scholarship Amount

The chapter will subsidize up to 75% of the course tuition.

Minimum Qualifications

Applicants must:

- Have a minimum of one year of experience in the real estate field
- Submit a complete official application as well as an employer affidavit indicating the employer's IREM course tuition reimbursement policy
- Be a Chapter 88 member who is current on both local and National dues
- Provide a letter of support from a IREM member or a Real Estate Management Professional
- Provide a brief statement of need and include a statement on candidate's dedication to the profession of real estate management
- Be approved by the Chapter Scholarship Committee and include the IREM course the candidate will select if scholarship funds are awarded.

Selection Criteria

- Applicant must: Possess a strong commitment to the profession of real estate management
- Possess a personal commitment to gaining the ARM or CPM designation.



Administration of the Scholarship Program

A person cannot receive additional scholarship until the completion of a previous scholarship award. Recipients may reapply for additional scholarship funding if needed upon completion of the current scholarship.

Applicants are evaluated and scholarships awarded as submitted. Submission shall be no later than 60 days prior to the selected course date. Scholarship to be used for the selected course only.

Scholarships must be used for IREM courses. The scholarship does not cover the cost of fees (i.e. application fees and management plan registration fee), dues, travel-related expenses or any other expenses.

Scholarship recipients must register for the course as prescribed by IREM National within the scholarship award letter. Scholarship funds will be paid directly to the Chapter or to the entity offering the course.
