What it's all about:

This position is accountable for overseeing and administrating federal and state rental subsidy programs serving predominantly very low and highly low-income Rhode Islanders. The incumbent also assists the Division Director in formulating policies, financial and strategic planning, addressing legislative issues, and overseeing operating functions as required. The successful candidate will manage complex operational programs while strategically developing and enhancing broad corporate policy goals by fostering relationships with community partners and federal, state, and local housing and supportive service agencies. The incumbent will establish and maintain performance standards, develop, and implement appropriate training programs, and aid in resolving complex operational and human resource issues. The incumbent will provide leadership and direction to Leased Housing and Rental Services staff by developing clear policies and procedures that will deliver exceptional results while ensuring RIHousing's compliance with applicable federal and state.

What you'll do on a daily basis:

Direct responsibility for oversight of staffing of the Housing Choice Voucher, Family Self Sufficiency and Special Program teams. They must ensure that all program activities and housing providers are maintaining compliance with federal and state regulations governing the programs.

Approves and authorizes disbursements and requisitions of monthly and quarterly HUD subsidies, HUD annual contribution contracts, voucher contracts and state rental assistance funds.

Develops and implements policies, procedures, and systems to effectively administer rental assistance programs and monitors the physical condition of properties within these programs. They ensure that all procedures are in compliance with internal polices and regulatory guidelines. In this regard, incumbent keeps current on applicable federal/state laws and regulations; advises staff of changes; and ensure that current procedures are being properly maintained and adhered to.

Meditates and resolves problems with and between landlords and program participants and they develop and deliver training and technical assistance to community partners.

Assists the Division Director in overseeing other functions within the Leased Housing and Rental Services Division on a daily basis. In this regard, they must be well versed in all aspects of housing management including systems and technology, as well as annual budgeting. Incumbent maintains strong working relationship with the local and regional offices of HUD's

Office of Public and Indian Housing, various state agencies and represents Rhode Island Housing in community activities and industry organizations.

Responsible for developing and maintaining positive working relationships with a variety of external partners and vendors including attorneys, private landlords, government agencies, and appropriate trade organizations.

Work closely with Senior Management throughout the Agency, but particularly with Leased Housing and Rental Services and the Executive divisions to form strategies around the effective utilization of programs to aid in addressing the homelessness crisis in Rhode Island. They will serve on committees and task forces and perform special projects related to state housing needs as assigned by the Division Director and Executive Director.

What you'll bring to the team:

- Manage the daily operations of the Housing Choice Voucher, Family Self Sufficiency and Special Program teams to ensure quality standards are met and RIHousing remains compliant with applicable laws, regulations, policies, and procedures. This includes direct supervision of a large team of 15-20 professionals as well as assisting the Division Director with personnel management of the entire Division.
- Resolve complex policy and compliance issues to minimize liability and risk exposure to RIHousing.
- Provide thoughtful feedback related to maximizing RIHousing's utilization of program resources.
- Strategize regularly on the effectiveness of rental assistance programs used to help address the housing and homelessness crises in Rhode Island.
- Mediate and/or resolve disputes between landlords and residents, ensuring ongoing compliance with Fair Housing laws.
- Assist the Division Director in overseeing other functions within the division and with financial/strategic planning as required.

- Minimum seven years of experience in managing assisted housing programs including staff supervision and training, with demonstrated knowledge of laws, regulations, and accounting guidelines for both federal and state rental housing programs.
- A strong understanding of and experience working with HUD's Office of Public and Indian Housing, particularly the Housing Choice Voucher and Family Self Sufficiency Programs.
- Strong knowledge and understanding of laws, regulations and guidelines governing affordable multifamily rental housing.
